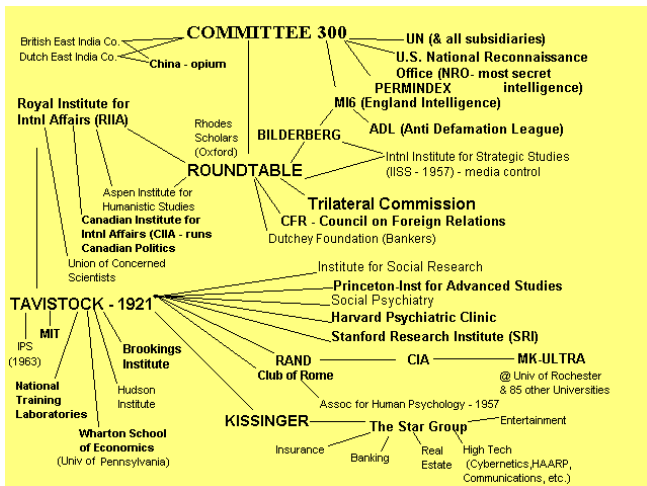

The political world of the Open Conspiracy must weaken, efface, incorporate and supersede existing governments. The Open Conspiracy is the natural inheritor of socialist and communist euphemisms; it may be in the control of Moscow before it is in the control of New York. The character of the Open Conspiracy will now be plainly displayed. It will be a world religion. Who are the planners and plotters who serve the mighty all powerful Committee of 300? The second America, in part, will consist of small businessmen and other independent spirits who manage to do well without corporate attachments. (19) To give the fullest support to supranational institutions such as the United Nations, the International Monetary Fund, the Bank of International Settlements, the World Court and as far as possible, cause local institutions to become less effective and gradually phasing them out or bringing them under the mantle of the United Nations.

(20) To penetrate and subvert all governments, and work from within them to destroy the sovereign integrity of the nations represented by them, under the guise of spreading "democracy" as a bulwark against terrorism.

Zbigniew Brzezinski in his book 'Between Ages, America's Role in the Technetronic Era'

The capacity to assert social and political control over the individual will vastly increase. It will soon be possible to assert almost continuous control over every citizen and to maintain up-to-date files, containing even the most personal details about health and personal behavior of every citizen, in addition to the more customary data. These files will be subject to instantaneous retrieval by the authorities. Power will gravitate into the hands of those who control information. Britain has begun the preparation of an "Identity Card" program. British citizens who apply for a passport or a driver license will be forced to produce a biometric Identity Card in which every single personal detail is encoded. and front organizations, including scores of teams of "specialist writers," that run the whole gamut of private business and government leaders. We will mention as many as we can, starting with the German Marshall Fund.

Its members -- and remember they are also members of NATO and the Club of Rome -- consisted of David Rockefeller of Chase Manhattan Bank, Gabriel Hague of the prestigious Manufactures Hanover Trust and Finance Corporation, Milton Katz of the Ford Foundation, Irving Bluestone, chairman of the United Auto Workers Executive Board, Russell Train, U.S. president of the Club of Rome and a member of Prince Philip's World Wildlife Fund, Elizabeth Midgely; CBS programs producer, B.R. Gifford, director of the Russell Sage Foundation, Guido Goldman of the Aspen Institute, the late Averill Harriman, Committee of 300 extraordinary member, Thomas L. Hughes of the Carnegie Endowment Fund, Dennis Meadows and Jay Forrester of MIT, noted for their "world dynamics." Since 1991 new members have been added including Silvio Berlusconi, Madeleine Albright, William Jefferson Clinton and several less well-known figures.

The Committee of 300, although in existence for more than 150 years, did not take on its present form until around 1897. It was always given to issuing orders through other fronts, such as its Royal Institute for International Affairs (RIIA). When it was decided that a super-body would control European affairs, the RIIA founded the Tavistock Institute, which in turn created the Club of Rome and then NATO. For five years, NATO was financed by the German Marshall Fund.

While the Bilderberg [Group] organization is an important part of the "300," the Club of Rome (COR) is indeed on a higher level of access to the supreme ruling body.

Public opinion-making is the jewel in the crown of the Olympians (the inner circle of the Committee of 300) for with thousands of new science social scientists at their beck and call, and with the news media firmly in their hands, new public opinions on almost any subject can be created and disseminated around the world in a matter of an hour or even less.

In 1991 President George Herbert Walker Bush was ordered by Margaret Thatcher on behalf of the "300"[Committee of 300] to take a belligerent stance against Iraq. Within two weeks, not only in the United States, but in almost the entire world, public opinion was turned against Iraq and Saddam Hussein.

... The Club of Rome reported to the Committee of 300, at whose head sits the Queen of England. Her Majesty rules over a vast network of closely-linked corporations who pay no taxes, and are answerable to no one; who fund their research institutions through foundations whose joint activities have almost total control over our daily lives.

... These linked institutions and their leading personnel form an upper-level parallel government that controls the lives of every American, whether they know it or not. Together, the interlocking corporations, insurance companies, banks, finance corporations, the mega-oil companies, newspapers, magazines, radio and television broadcasting companies they make up a vast apparatus that sits astride the United States and the world. There is not a politician in Washington, D.C. who is not somehow beholden to it.

The problem with the Left is that it is run by the very same people who control the Right.

p194

The governments of Great Britain and the United States already have the machinery in place to bring the American people into line in a New World Order... The machine has been gaining in size and strength since 1946. Each passing year has added new layers and new refinements and new strengths, to the upper-level parallel secret government that has successfully usurped total control over the United States. It is the Committee of 300 [which] established control network and mechanisms far more binding than anything ever seen in this world. Chains and ropes are not needed to restrain the American nation. Fear of what is to come does that job far more efficiently than would any physical means of restraint.

The intent and purpose of the Committee of 300 is to bring to pass the following conditions: A One World Government and one-unit monetary system, under permanent non-elected hereditary structure, who self-select from among their numbers to work toward a return to the feudal system of the Middle Ages in which the One World population will exist. In this One World entity, population will be limited by restrictions on the number of children allowed per family; diseases, wars and famines will take care of 'excess population" until 1 billion people, who are useful to the ruling class in areas which will be strictly and clearly defined, will remain as the total population of the world. There will be no middle class, only rulers and servants.

The Committee [of 300] is the ultimate secret society made up of an untouchable ruling class, which includes the Queen of England, the Queen of the Netherlands, the Queen of Denmark and the royal families of Europe. The Assassination Bureau ... exists in the United States and Europe and carries out high-level assassinations where all other remedies have failed. One such bureau called PERMINDEX ran the on-the-ground Kennedy assassination under the direction of Sir William Stephenson, for years the Queen of England's leading "pest controller."

... the FBI, Secret Service and CIA knew exactly how to strip President Kennedy of his security motorcycle detail and make it easy for the three PERMINDEX shooters to murder him in Dealey Plaza in November of 1963.

In 1951 Sir William Stephenson of M16, restructured the [Israeli intelligence agency] Mossad

into a single unit as an arm of the Political Department of the Israeli Foreign Office and assigned the task of conducting intelligence gathering. It was also given the job carrying out "black job" operations.

... All Mossad agents, operate on a war-time footing. The Mossad has a tremendous advantage over other intelligence services in that every country in the world has a large Jewish community, which is useful.

The Mossad also has the advantage of having access to the records of all U.S. law enforcement agencies and U.S. intelligence services. The office of Naval Intelligence (ONI) services the Mossad at no cost to Israel.

... The Mossad has a skillful disinformation service. The amount of disinformation it feeds to the American "market" is embarrassing, but even more embarrassing is how America swallows hook, line and sinker such propaganda.

President Kennedy['s] assassination was carried out with great attendant publicity and with the utmost brutality to serve as a warning to world leaders not to get out of line.

The existence of the National Reconnaissance Office (NRO) was known to only a handful of people outside of the Committee of 300... the NRO annual budget is not known to the Congress of the United States, and it answers only to a selected few in Congress. But it is creature of the Committee of 300, to whom its reports are routinely sent very few hours.

p344

Military Intelligence Department Six dates back to Sir Francis Walsingham, spymaster of Queen Elizabeth I for dirty tricks operations. Over hundreds of years, M16 has established a legendary record which no other intelligence agency can come close to duplicating.

... M16 agents have gathered information from the four corners of the earth and have carried out secret operations that would astound even the most knowledgeable, if ever they were to be made public, which is why it rates as the key service of the Committee of 300.

Before changes made in 1998, officially M16 did not exist. Its budget comes out of the Queen's purse and "private funds," but is reported to be in a range of \$450 to \$650 million per annum. No one knows for sure what the exact amount is. In its present form, M16 dates back to 1911.

... Unlike other services, future members [of M16] are recruited from universities and other areas of learning by highly skilled "talent scouts," as in the case of Rhodes Scholars inducted into the Round Table .

... With backing from such a formidable force, the Committee of 300 had little fear from ever being exposed, and this will continue for decades. What makes the Committee incredible is the veil of secrecy which prevails. Up to recent times none of the news media had made mention of this conspiratorial hierarchy.

The Committee of 300 is for the most part under the control of the British monarch, in this case, Queen Elizabeth II.

... The Committee of 300 has members among the British aristocracy, who have corporate business interests and associates in every country of the world, including Russia.

Banking, while not its mainstay [Committee of 300], it is of vital importance, especially following the burgeoning drug trade that began in 1997, for which its banks act as clearing houses and money launderers of billions of dollars derived from drug money. The main "big name banks" are:

- o The Bank of England
- o The Federal Reserve Banks
- o Bank of International Settlements
- o The World Bank
- o The Hong Kong and Shanghai Bank
- o American Express

American Express Bank Travelers checks are a convenient method of recycling drug dollars. Each of these banks is affiliated with and/or controls hundreds of thousands of large and small banks throughout the world. Banks large and small in the thousands are in the Committee of 300 networking cycle.

The Oppenheimer dynasty of South Africa ... is as important as the Rockefeller's dynasty... Harry Oppenheimer, chairman of the giant Anglo American Corporation, controls gold and diamond mining, sales and distribution all over the world.

... The only other company to rival Oppenheimer in the field of precious metals and minerals, Consolidated Gold Fields of South Africa, was taken over by Oppenheimer with a 28 percent stake, as the largest single stockholder. Thus, gold, diamonds, platinum, titanium, tantalite, copper, iron, tungsten and uranium, plus 52 other metals and minerals, many of them of absolutely vital strategic value to the United States, passed into the hands of the Committee of 300.

Nothing happens on Wall Street that is not known to the Bank of England, whose instructions are relayed through the Morgan Bank and then put into action through key brokerage houses, whose top executives ultimately responsible for carrying out Committee directives.

p353

Some of the richest families in the world live in Europe, so it is natural that they should have a preponderance of members on the Committee. The Von Thurn and Taxis family, who once owned the entire European postal franchise, make David Rockefeller look like a very poor relation. The Von Thurn and Taxis dynasty dates back for more than 300 years, and generation after generation of family members have had seats on the Committee, which one of them occupies to this day. Their history is closely linked to the Rothschild dynasty for whom they acted as Postal interceptors for them at crucial points in history.

Committee of 300 corporations, banks and insurance companies operate under the unified command structure covering every conceivable matter of strategy and cohesive action. The

Committee is the only organized power hierarchy in the world transcending all governments and individuals...

... There is no entity the Committee cannot reach and control, and that includes the organized religions of the world. This then, is the all powerful "300" with its inner circle of "Olympians," whose power base is in London, and the City of London financial center, with its grip on minerals, metals and precious gems, cocaine, opium, pharmaceuticals, renter-financier bankers, cult promoters and founders of rock music. The British Crown is the control point from which all things radiate.

The Rank Organization ... in conjunction with Eagle Star is virtually the British Royal Family. It is also the black operations center of M16 (SIS). Between them, the two Committee of 300 companies control Her Majesty's Dominion of Canada, using the "hofjuden" Bronfman family to carry out their orders.

Trizec Holdings, ostensibly owned by the Bronfman family is in reality the main asset in Canada of Queen Elizabeth. The entire Southeast Asian opium trade interfaces with the Bronfman dynasty and is one of the means whereby heroin is brought to America. In a sense, Canada is like Switzerland; pristine snow-covered landscapes, big cities, a place of great beauty. But underneath it are found layers of unsavory companies forming the backbone of the massive, underground heroin trade.

From documents covering the First World War I was able to gather and examine in the War Office in Whitehall, London, it appears that the Tavistock Institute of Human Relations was commissioned by the Committee of 300 to prepare a study on manipulating war information, or in plain English, waging a propaganda war. The task was given to Lord Northcliffe, Lord Rothmere and Arnold Toynbee, at that time an M16 operative working at the Royal Institute for International Affairs (RIIA). Lord Rothmere's family owned a newspaper chain, which could be utilized to support various government positions, so it was thought that the public perceptions, especially among the ranks of the growing opposition to the war, could be influenced and turned around.

The project was based at Wellington House, named after the Irish aristocrat Arthur Wellesly, the Duke of Wellington. American specialists drafted to help Lords Rothmere and Northcliffe included Edward Bernays and Walter Lippmann. Incidentally, Bernays was the double nephew of Sigmund Freud. The group held "brain storming" sessions to work out techniques for mobilizing mass support for the war, especially among the working class people whose sons would be going to the slaughter fields of Flanders in record numbers.

Using new manipulative techniques for a period of about six months, it became apparent that the techniques were going to be a success. What the researchers discovered was that only a very small group of people understood the process of reasoning and they had the ability to observe the problem, as opposed to passing an opinion on it. That, said Lord Rothmere, was the way of thinking of 87 percent of the British people's approach to the war, and that the same principle applied not only to the war, but to every conceivable problem in society in general.

In this manner, irrationality was elevated to a high level of public consciousness. The manipulators then played upon this factor to undermine and distract the grasp of reality governing any given situation. The more complex the problems of a modern industrial society, the easier it became to bring greater and greater distractions to bear. The end result was the

absolutely inconsequential opinions of masses of people, created by skilled manipulators, which then assumed the position of scientific fact. Having literally stumbled upon so profound a conclusion, the manipulators put it to one test after another before the war, and were able to turn public opinion, previously opposed to war by a large majority, to support for the coming war that nobody among the people seemed to understand the need for. During the terrible, bloody war that erupted in 1914, in spite of hundreds of thousands of the youth of Britain being slaughtered on the battlefields of France, there was virtually no organized, serious opposition to the war.

Records of the period show that by 1917, just before the United States entered the war, 94 percent of the British working class bearing the brunt of the war, did not have the faintest idea what they were fighting for, other than the image created by the media manipulators; that the Germans were a horrible race, bent upon invading Britain destroying the monarchy and the nation. Therefore, in consequence, Germany had to be wiped off the face of the earth.

It was no accident that Kissinger chose President Nixon's old hangout, the Hotel Pierre in Manhattan, as his center of operations. The significance of the Round-Table-Kissinger operation was this:

On the orders of RIIA chairman Andrew Schoefield, a block was placed on all agencies involved in intelligence. The block was to prevent them from giving information to President Nixon, without it first having been cleared by Kissinger. This gave Kissinger the opportunity to vet all intelligence, foreign and domestic and law enforcement information, including FBI Division 5 reports, before any of it was released to the president. The arrangement made certain that all M16-controlled terrorist operations in the United States were leak-proof. This was Morton Halperin's bailiwick. In 1993, President Clinton nominated Halperin for a senior post in his cabinet, but in December 1993 his nomination was held up by a Senate committee.

By following the methodology laid out for him, Kissinger at once established hegemony over the Nixon presidency. And after Nixon was disgraced and hounded from office, Kissinger emerged with unprecedented powers, which became standard for all future White House controllers. Some of these seldom enumerated powers included the following:

Kissinger ordered National Security Decision Memorandum No. 1 to be drafted by Halperin who took the actual wording directly from the RITA, via Round Table circles. The memorandum

appointed Kissinger as the supreme U.S. authority, and chairman of the Verification Panel. All SALT negotiations were directed from Kissinger's office, using Paul Nitze, Paul Warnke and a nest of New World Order specialists inside the Arms Control Mission at Geneva. This committee would block crucial information from reaching President Nixon. In addition, Kissinger was appointed to oversee the Vietnam Special Studies Group that made evaluations of all reports, civilian and military, including intelligence reports, coming out of Vietnam. Kissinger also demanded and got oversight of the "40 Committee," a super-secret agency that had the task of deciding when and where to initiate covert activities, and then monitored the progress of operations it set in motion.
